- 1. Targets were not set for the Measurable Skill Gains performance indicator.
- 2. Reporting of the Youth program's median earnings to the federal government is not required.

2018 Performance measures improved over 2017.

Adult program exceeded performance goals in all measures except for employment within 6 months of exiting the program. The percentage of adult participants who held employment within 12 months surpassed the target of 63.9% to an actual rate of 66.7%.

Adults who earned credentials surpassed the target of 51% to actual rate of 62.5%. Credentials target for dislocated worker and youth program would have been met if 1 more participant in each had earned credentials. We missed the target by 1%.

The youth program met the goals for employment, education or training within 6 months. However, remained weak for same categories within 12 months of exiting the program.

Employment rates fell short of meeting the targets in the dislocated worker program.

Median earnings performed well for adult and dislocated worker programs, where adult participants earned \$5,367 in median wages and dislocated worker participants earned \$7,963 in median wages.

## PY18 STATEWIDE RAPID RESPONSE ACTIVITIES

JULY 1, 2018 TO JUNE 30, 2019

#### **OAHU**

24 Worker Adjustment and Retraining Notification (WARN) letters received from Oahu businesses.

WDC followed up on 18 news reports and rumors of struggling businesses.

Rapid response team conducted 5 support sessions serving 216 individuals.

#### **HAWAII**

5 WARN letters received from Hawaii County businesses.

2 rapid response sessions in Hilo and Kona were conducted serving 90 people.

#### KAUAI

1 WARN letter was received from a Kauai business.

1 rapid response session was conducted serving 25 people.

#### **MAUI**

4 WARN letters received from Maui businesses.

Rapid response assistance was provided to 5 workers.

Total workers served = 336

## USDOL DISASTER DISLOCATED WORKER GRANT

#### **KAUAI COUNTY**

WDC and Kauai AJC participated in 4 community-sponsored events focused on island-wide disaster recovery assistance in Koloa, Anahola, Hanalei and Lihue.

Additionally, WDC and Kauai AJC held 2 disaster information and recruiting sessions on the North Shore in Hanalei.

WDC gave radio interviews on KKCR Kauai Community Radio and Hawaii Public Radio.

There were 3 active recovery worksites and 6 workers. To date \$88,397 expended out of the \$500,000 grant.

Worksites: National Tropical Botanical Garden Limahuli Preserve temporarily employs workers to repair infrastructure damage and maintain plant collections.

Makana O Kauai, a scuba-based debris collection project removes storm debris from nearshore waters and coral reefs.

Mea'ai on Wheels is a humanitarian recovery project providing meals to impacted elderly, frail ad sick isolated North Shore residents. This projected ended when Kuhio Highway reopened to the public and lost matching county operating funds.

#### **HAWAII COUNTY**

WDC and Hawaii County AJC conducted 3 information and recruiting sessions in East Hawaii.

There are 2 recovery worksites and 9 workers. At one time, there were 15 participants. To date \$338,944 has been expended out of the \$3.5 million grant.

Worksites: UH Hilo College of Tropical Agriculture and Human Resources (CTAHR) Waiakea Station. Workers are recovering the local agriculture industry through pest and disease research, and healthy starter root stocks.

Hawaiian Sanctuary, workers are recovering the demonstration farm which offers free subsistence agriculture classes and serves as a community gathering place.

WDC contracted a staffing agency, Hawaii Employment Services to manage payroll/benefits for participants.

USDOL recommended WDC contract a project operator for each county to recruit eligible dislocated workers impacted from the disaster with approved worksites. WDC will modify the current contract with Hawaii Employment Services to provide these additional services.

Federal grants and local contracts end June 30, 2020.

## AMERICORPS VISTA PROGRAM

### CORPORATION FOR NATIONAL & COMMUNITY SERVICE

#### OAHU - WDC

Keana Kaupiko started September 3 and is located in the WDC office.

Living allowance of \$1,500 per month paid by VISTA directly to worker for one year.

Keana is working with Oahu AJC business services team and statewide rapid response activities to develop policies and procedures. She also monitors the Maui VISTA worker.

Challenge: Locating affordable housing. Fortunately Keana's family lives in Kailua and she is able to have comfortable housing and good public transit to bus to work. She also has access to a car when needed.

#### MAUI

Scarlett Munoz-Perez started on October 28 and is located in the Maui Economic Development Office and AJC.

Living allowance of \$1,500 per month paid by VISTA directly to worker for one year.

Scarlett is working on learning Maui's current level of business engagement, outreach materials, policies and practices.

Challenge: Affordable housing is very hard to located on Maui. If not for the assistance of Karen Arakawa, the One Stop Operator, Scarlett would not have been able to find a place to stay. The Executive Director provided a bike for her to ride and she takes the bus to work.

Lack of affordable housing on Kauai prevented a VISTA worker to be assigned. Hawaii County did not wish to participate in the program.


