Dear Director Murakami:

Pursuant to the Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 *et. seq.* (1988), this is to inform you that **GP/RM Prestress, LLC** may need to initiate a "mass layoff." The name and telephone number of **GP/RM Prestress, LLC** official to contact for further information is Andy Boyd, President, at (808) 682-6454. If we need to initiate this action it is expected to be temporary. We anticipate being able to hire back some if not all of the laid off workers as our business picks up.

We have initiated two layoffs (12/19/2019 & 1/6/2020) which brings the total number laid off to 47 and whose job titles are as follows:

Laborer

At this time, we do not anticipate any future layoffs, but if the business conditions do not improve we may need to take additional action.

**The job titles, date and numbers of future layoffs, if any, are undetermined at this time.**

Bumping rights do not exist.

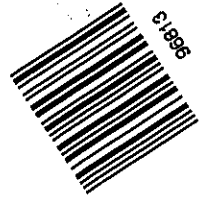
