To Whom it May Concern:

Please be advised that Oakwood Worldwide (US) LP (“Oakwood” or the “Company”) is undergoing an additional reduction in its workforce on March 30, 2020, which will result in a permanent layoff of one (1) employee who works remotely for its office at Shawline Street Suite B, San Diego, CA 92111 from Honolulu, Hawaii, due to streamlining of the organization in light of new corporate goals.

A list of the affected job titles and the number of employees per classification for Oakwood’s first reduction in force that occurred on December 30, 2019 (attached as **Exhibit 1**) and additional reduction in force that is scheduled to occur on March 30, 2020 (attached hereto as **Exhibit 2**). The layoffs will be permanent. No union represents the affected employees and no bumping rights will exist. The separations will be effective March 30, 2020. The site is not closing in its entirety.

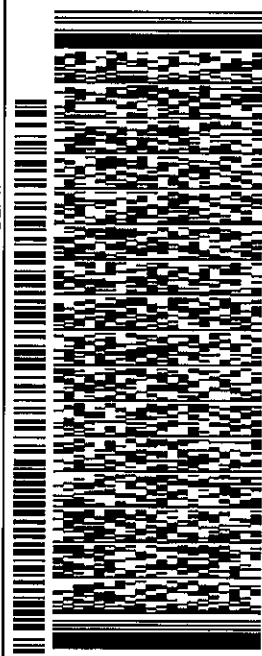

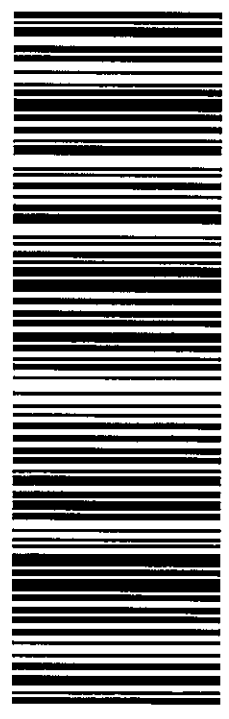
