Based upon the rapidly changing circumstances, we are providing you with shortened notice pursuant to the unforeseen business circumstances exception in 29 U.S.C. §2101(b)(2)(A).

Pursuant to the Worker Adjustment and Retraining Notification Act, this is to inform you that, Halepuna Waikiki at 2233 Helumoa Road, Honolulu, Hawaii 96815, will be extending its temporary closure due to unforeseen business circumstances, and will therefore continue the layoff of almost all of its employees. This will be a temporary transaction. There are no bumping rights.
