Dear Acting Director Perreira-Eustaquio:

This letter is to inform you, pursuant to the Worker Adjustment and Retraining Notification Act ("WARN"), that Kaiser Foundation Hospitals and Kaiser Foundation Health Plan, Inc (the Employer) intend to permanently to lay off certain employees at various Hawaii locations. No Employer locations are closing. The notification is being provided in the event more lay offs become necessary.

Employees will be notified of layoff on August 13, 2020. We anticipate that the termination date will be at the end of the sixty (60) day notification period. No bumping rights exist for these non-represented employees.

The list enclosed as Exhibit A provides the job titles of positions to be affected by the layoff, location for the position, and the number of affected employees within each affected job classification by location.

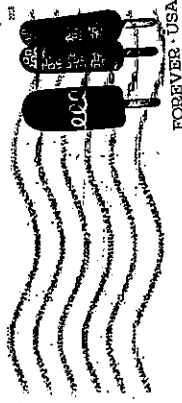

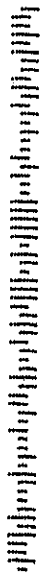
