Re: Amended Notice of Mass Layoff at Hawaiian Airlines

Dear Ms. Perreira-Eustaquio:

Reference is made to my July 29, 2020 letter, which constituted Hawaiian Airlines, Inc.'s ("Hawaiian's" or the "Company's") notice pursuant to the federal Worker Adjustment Retraining Notification Acts ("WARN Act Notice"). This letter is an update to that WARN Act Notice.

We previously notified the Department of Labor & Industrial Relations that Hawaiian anticipated that 35% or 2037 union employees in Hawai'i may be involuntarily furloughed no earlier than October 1, 2020. As was set out in the WARN Act Notice, that projection was subject to change depending on the outcome of the voluntary furlough program. The election periods for the voluntary furlough programs for the unions have now closed. With the unions' support and the support of their members, the Company was able to reduce the number of involuntary furloughs from 2037 to 192 union employees. Accordingly, Hawaiian has adjusted its July forecast.

Exhibit A is an amended listing of the potentially affected job classifications for union employees residing in the State of Hawai'i and the number of potentially affected employees in each job classification.
