This letter is to provide you with updated information in follow up to our prior correspondence, dated August 28, 2020. In our August 28, 2020 letter, we noted that we had hoped to bring furloughed employees back to work on or around October 15, 2020. Based on our current projections, we now anticipate the majority of our employees will remain furloughed until at least December 1, 2020, although we hope to start bringing some employees back to work beginning this month. That projection is subject to change depending on the rapidly changing economic and other conditions relating to the COVID-19 pandemic.
