Re: WARN Act Notice

Dear Director Perreira-Eustaquio:

This letter is to inform you, pursuant to the Worker Adjustment and Retraining Notification Act ("WARN"), that Kaiser Foundation Hospitals and Kaiser Foundation Health Plan, Inc., (the Employer) intend to permanently layoff certain employees at various Hawaii locations. No Employer locations are closing. We notified you on August 13, 2020 that 29 employees were permanently laid off.

On October 22, 2020, 5 employees were notified and today, 40 employees will be notified of layoff. We anticipate that the termination date will be at the end of the sixty (60) day notification period. No bumping rights exist for these non-represented employees.

The list enclosed as Exhibit A provides the job titles of positions to be affected by the layoff, location for the position, and the number of affected employees within each affected job classification by location.

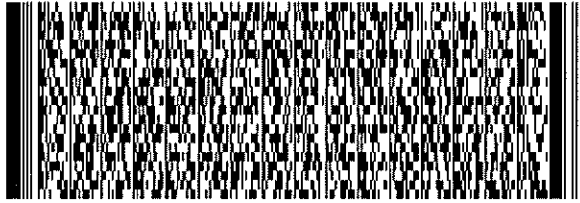

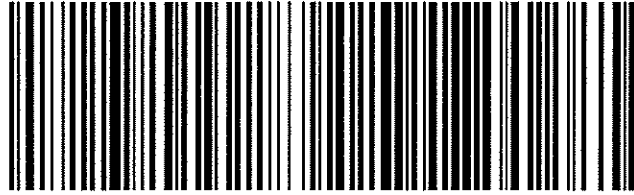
