II. Approval of Minutes for the August 26, 2020 MVAC Meeting

Mr. Olds requested a motion to approve the minutes. Roman Galiki moved to approve the minutes of the August 26, 2020 meeting. Mildred Lonergan seconded the motion. The motion to approve the minutes was approved unanimously.

III. Information and Updates

A. Ship Repair Association of Hawaii (SRAH)

Iain Wood reported that the outlook for shipyard and ship repair work on the Navy base is strong and close to one billion dollars over the next five years. The Navy is transitioning to a fixed price structure with multiple companies acting as prime contractors. This may help the industry grow in Hawaii as they increase capacity and hire locally. Some work had previously been pushed to the mainland so this is an opportunity to demonstrate to the Navy that their needs can be executed in Hawaii. Recent jobs in Hawaii include the USS Michael Murphy, USS Wayne Meyer, and USS Chung Hoon. The industry also supports the U.S. Coast Guard and other Military Sealift Command in the commercial sector in addition to the Navy and Missile Defense.

Ini Patelesio reported that Pacific Shipyards has been growing rapidly with an average of five new hires a week over the past five weeks with the new contract structure. They are always looking for welders, mechanics and electricians. The administration side is also growing. Melissa Hieda reported that she is currently recruiting for Environmental Health and Safety Technicians, Marine Machinists, and an Assistant Production Manager. Angela Para reported that she is recruiting for an IT Director, Sandblaster Cleaners, General Laborers, Facilities Maintenance Technician, a CDL Class B Driver, and an Equipment Reconditioning Technician. A list of positions and position summaries will be sent to the group.

B. Military Spouse Subcommittee

Mr. Galiki reported that the subcommittee met on October 23. The purpose of the meeting was to reorient and rekindle conversations about military spouse employment transition issues since it has been about a year since the group last met. The group was asked to gather issues and concerns specific to their veterans, military personnel and spouses for discussion at the next meeting. Some issues to be discussed include internships available for military spouses in Hawaii, transfer of job licenses and credentials issued by other states to be accepted by Hawaii, military spouse preference to state agencies, and collaboration and partnership opportunities with other organizations.
