Pursuant to the Worker Adjustment and Retraining Notification Act, ((b) The “unforeseeable business circumstances” exception under section 3(b)(2)(A) of WARN applies to plant closings and mass layoffs caused by business circumstances that were not reasonably foreseeable at the time that 60-day notice would have been required) this is to inform you that Mauna Lani, Auberge Resorts Collection 68-1400 Mauna Lani Drive, Kohala Coast, Hawaii 96743 will be closing a few departments at the hotel due to the effects of COVID-19 and will therefore temporarily layoff some of its employees that were recalled to work when the hotel opened in November. Most of these layoffs will happen in January 2021. No bumping rights exist for the non-union employees.

A listing of the job classifications affected and number of affected employees in each job classification is attached.

ILWU Local 142 represents most of the hourly employees at the facility. We have a Memorandum of Agreement in place with the union as it relates to the effects of Covid-19 on our business.
