V. Status on Committee Budget Plan

The three Hui – Trauma-Informed Assessment (\$40,000), Work Experience/Transition to Postsecondary Education & Training (\$30,000), and Entrepreneurial Skills Training (\$50,000) – were turned over to the Oahu Workforce Development Board (OWDB) through their Youth Program and One-Stop Operator. The OWDB will take over stewardship of the collaboration and implementation of the three initiatives. It was determined that Oahu had sufficient funds to cover the cost of the projects and allows the projects to be implemented on Oahu. The original budget would have required statewide projects.

- A. Entrepreneurial Skills Training with Oahu American Job Center by Steve Sue The Oahu American Job Center is working on finalizing and executing the contract so that the Entrepreneurial Skills Training can begin in February 2021. There are four entrepreneurial one-month experiences including culinary, agriculture and construction industry, maker of products, and apps for technology. Curriculum was written specially for this program and is focused on social venture.
