I. Call to Order

A. Chair's Updates by Chair Leslie Wilkins

Chair Wilkins called the meeting to order at 9:34 a.m. and declared that quorum was achieved. Chair Wilkins thanked General Edward Richardson for his work on the Military and Veterans Affairs Committee and the Executive Committee. General Richardson has resigned from the Board due to health reasons but will remain as a committee member of the Military and Veterans Affairs Committee. Chair Wilkins thanked Vice Chair Alan Hayashi for stepping in as Interim Committee Chair. Chair Wilkins also announced that Bernadette Howard has stepped up as Vice Chair of the Sector Strategies and Career Pathways Committee, joining Committee Chair Yvette Gibson to lead the committee.

Chair Wilkins announced that on January 21, she participated in the National Governors Association peer-to-peer learning opportunity for states that received the USDOE's Reimagine Workforce grant. Hawaii was one of eight states to be awarded \$13.3 million in partnership with WDC and the University of Hawaii.

The basic computer skills class will likely have an April launch date. It will be a statewide, 3-hour class in various locations such as libraries, community centers, and the American Job Centers for around 3 to 10 participants at a time. The MOA with the UH Community Colleges runs through June 2021 for this pilot program. WDC is partnering with the State Libraries for the curriculum through Northstar Digital Literacy and they will provide a digital literacy assessment, curriculum, and ability to tag and track participants. There will be a pre-pilot run of the program at Salt Lake library on March 20 and 27.

WDD contracts the City to provide services to youth under the Disability Employment Initiative and were able to pivot services to the disabled youth during the pandemic through videos.
