Ms. Leong-Yep has reached out to the community leaders of Waipahu where they have successfully managed to break the comfort barriers.
- -On Nov 15, 2021 the committee will hold an online informational meeting with leaders of the Micronesian community. The presentation will be done by AJC Employment Consultant, Esther Lokboj. -Subcommittee members participated in hiring events on Maui and Oahu in August. Planning future webinars.
- -This subcommittee is open to feedback, suggestions on supporting, and connecting jobseekers and employers.
- -Melissa Gerber of Abilities Unlimited is interested in being a subcommittee member. Her program is in numerous high schools. Ms. Gerber has ideas of how to get more students involved.
