## II. Approval of Minutes

## A. November 18, 2021, Meeting

Chair Hayashi requested a motion to approve the minutes for the November 18, 2021, meeting. Sean Knox moved to approve the minutes of the November 18, 2021, meeting. Cary Miyashiro seconded the motion. There were no objections or abstentions. The motion to approve the minutes was approved unanimously.

## A. February 10, 2022, Meeting

Chair Hayashi requested a motion to approve the minutes for the February 10, 2022, meeting. Brian Lee moved to approve the minutes of the February 10, 2022, meeting. Yvette Gibson seconded the motion. There were no objections or abstentions. The motion to approve the minutes was approved unanimously.

## III. Executive Session

Chair Alan Hayashi used Chair's prerogative to move the Executive Session forward, all current board members that were present were put into Executive Session. Chair Hayashi explained the purpose of the Executive Session is to discuss the evaluation of the Executive Director, and if agreed, to extend the position another year to June 30, 2023.

The WDC board members entered Executive Session at 9:52 a.m.

The Executive Session ended at 10:21 a.m.

Chair Hayashi reconvened the public portion of the meeting. Vice Chair Brian Lee provided an overview of the performance evaluation process and outcomes. The performance review was conducted by the Executive Committee members using previously utilized evaluation tool rating of 1 to 5 in the categories of accountability, building trust, facilitating change, communication, prioritization, teamwork, critical thinking, customer/stakeholder focus, initiative, and goal accomplishment. Executive Director Allicyn Tasaka's average rating was 4.3 points out of 5 points.

Vice Chair Lee made a motion to accept the evaluation of the Executive Director as reviewed and based on the evaluation to extend Allicyn Tasaka in her capacity as Executive Director (with no salary increase) to June 30, 2023. The motion was seconded by Cary Miyashiro. Chair Hayashi conducted a roll call vote, and the motion was approved 23 in favor and one in opposition. The motion passed.

## IV. Presentation on the personnel and training needs of the aviation industry

Patrick E. McNamee, from the General Aviation Council of Hawaii provided an overview of the aviation industry. In 2017, there were 609,000 pilots across the country. At one time there were over 800,000 pilots but over time not enough pilots are being trained. Pilots face mandatory retirement at age 65 years. Delta Airlines purchased a flight school to train their own pilots. Mr. McNamee said that Hawaiian Airlines has 1,200 pilots, and will need many more as pilots reach the mandatory retirement age. Over the next 3 years, 754,000 mechanics will be needed. Flight attendants are in constant recruitment. Aviation Managers who operate the airports, which is like managing a little city (i.e., fuel, security safety, etc.). There is no training available for this position in Hawaii and is basically on-the-job-training.

• Brian Lee asked if there is enough flight simulation/ flight training equipment on the

island. Mr. McNamee stated that flight simulators are not the answer; he connected the leading causes of aircraft accidents to the misuse of flight simulators. Pilots must have actual air-time as part of the training.

- Chair Hayashi asked Cary Miyashiro to reach out and start the conversation with Mr. McNamee about possible career pathway goals.
- Vangie Casinas from the DOE Career Technical Education office stated that the transportation pathway was unveiled and the aviation maintenance technology program is stalled because of the lack of qualified teachers.

# V. Updates on the Department of Labor and Industrial Relations (DLIR) from February 11, 2022 to May 12, 2022

DLIR Deputy Director JoAnn Vidinhar extended her thanks on behalf of the Department to Patrick McNamee for the presentation on the aviation industry, and to the outgoing committee Chairs and Vice Chairs. Deputy Vidinhar welcomed the new members that will be joining the board on July 1.

Deputy Vidinhar shared that during the legislative session, through the approval of the budget bill, \$5.2 million and seven positions were received for fiscal year 2023 for a statewide internship program. The program will place 300 interns and 30 Department of Education students across State Departments. The IT internship pilot program, that was held in the state executive branch, which placed 40 IT students in state government positions will be ending soon.

# XI. Roundtable sharing by members relating to industry impact of COVID-19 pandemic and any sector concerns

Paxca President Kelly Ueoka shared how COVID-19 affected the IT industry, in the beginning it was actually in a way positive with the abundance of people doing remote work and need for cyber security. Paxca established a new Workforce Development division and hired a Workforce Development Director. They created the workforce section within Paxca to train people to learn and acquire certifications to qualify for jobs and remain in Hawaii. Paxca was able to fill vacancies through this program and have taken high school graduates who passed an aptitude test and do on-the-job-training while earning certificates and hiring them starting at \$50,000 with benefits.

Brand Industrial Group President Jason Brand explained that these are exciting times for the agriculture industry. Local demand is increasing and the state is working toward 30% of locally produced products by 2030. On the flip side, he talked about scalability and supply chain challenges. There are multiple negative effects on agriculture due to COVID-19, many farms were started two years ago, and that made the expense side for agriculture go up, such as the

price of fertilizer, and farms going bankrupt and/or shrinking their crops, as well as dealing with the high cost of labor compounded by labor shortages. Many farms have automated their systems for economical reasons.

Ian Kitajima shared that the COVID-19 rapid antigen test kit developed by Oceanit received FDA emergency use authorization. Less than 2% of companies that submitted for FDA approval have gotten approved.

Yvette Gibson shared a short update for the healthcare industry, training during pandemic slowed down to focus on more experienced workers in the healthcare industry, now training is more prevalent.
