WIOA Title I and III Performance Indicator Results for Program Year 2020

#### **PURPOSE**

This bulletin releases the results of the primary indicators of performance for the WIOA Title I and III programs for Program Year (PY) 2020.

## **BACKGOUND**

Section 116 of the Workforce Innovation and Opportunity Act of 2014 (WIOA) establishes a performance accountability system to assess the effectiveness of the State and local areas in achieving outcomes for individuals served by WIOA core programs. WIOA requires the State and Local Workforce Development Boards (LWDBs) to report primary indicators of performance and to meet specified performance targets as agreed with the U.S. Department of Labor, Employment and Training Administration (ETA). Training and Employment Guidance Letter (TEGL) No. 11-19 provides guidance on calculating the results of the primary indicators of performance.

#### **ACTION REQUESTED**

WIOA partners, LWDBs, and Workforce Development Division County Branch Offices should distribute this bulletin to relevant staff for review. Performance scores highlighted in red indicate areas that need to be improved. The bulletin may be used as a part of program planning and implementation to make improvements where needed.

## **DEFINITIONS**

Negotiated Level of Performance is a target goal that is mutually agreed upon before the start of a program year, first by the State and ETA for a Statewide performance indicator and then by the State and an LWDB for a local area performance indicator. The negotiated levels are written in the unified State plan.

Adjusted Level of Performance is an adjustment to a negotiated level of performance that is calculated after the end of a program year. The adjusted level factors in actual participant characteristics and current economic conditions for the program year that is being assessed.

Actual Level of Performance is the actual outcome for a performance indicator reported after the end of a program year in an ETA-9169 annual report.

**Individual Indicator Score** represents how well a performance indicator has performed based on the adjusted level of performance. It is calculated by dividing the actual level of performance by the adjusted level of performance.

**Overall Program Score** is the average of individual indicator scores for a single WIOA program. This score indicates how well an entire program has performed in view of all the performance indicators associated with that program.

**Overall Indicator Score** is the average of the indicator scores for the same performance indicator across the WIOA Adult, Dislocated Worker, and Youth programs (three WIOA Title I programs). This score indicates how well a particular performance indicator has performed across the three WIOA Title I programs.

### PERFORMANCE RESULTS

Tables 1 to 5 provide the results for the WIOA Title I Adult program for the State and each local area. Tables 6 to 10 provide the results for the WIOA Title I Dislocated Worker program for the State and each local area. Tables 11 to 15 provide the results for the WIOA Title I Youth program for the State and each local area. Table 16 provides the overall indicator scores across the WIOA Title I programs for the State and each local area. Tables 17 to 21 provide the results for the WIOA Title III Wagner-Peyser program for the State and each local area. All results are for Program Year 2020.

Performance scores highlighted in red indicate areas that need to be improved.

In sum, improvement is mostly needed to achieve credential attainment and measurable skill gains in the County of Kauai and County of Maui. Of all the local areas, the County of Kauai needs the most technical assistance in order to make significant improvements in the WIOA Title I programs. The State of Hawaii performed at a satisfactory level overall in Statewide performance indicators. Statewide improvement should focus on the WIOA Adult and Youth programs. The State and all counties performed well across all performance indicators in the WIOA Wagner-Peyser program.
