# 6. Announcements & Public Testimony

Through the Sector Strategies & Career Pathways Committee, Laura Reichhardt, Director of Hawaii State Center for Nursing presented a Powerpoint on a proposed project. The committee approved Phase 1 to move the proposal from Committee to Executive Session for further discussion.

The projects' goal is to increase healthcare education capacity and to expand support of nursing clinical placements across the state and allied health. Currently, they are asking for full funding for Phase 1 which includes expanding to Maui and establish allied health HCPC Workgroup on Maui and Oahu starting January 1, 2023, through June 30, 2023. Also, in the proposed budget is 2 full time employees for 6 months and 10 CCPS/Software Licenses Fees.

Jarret is recruiting for a Program Coordinator who can assist with The Internship & Apprenticeship Initiatives. Jarret will email the link for the posting.
