Pursuant to the Hawaii Dislocated Workers Act, Hawaii Revised Statutes, Chapter 394B (“DWA”) and to the extent applicable pursuant to the Worker Adjustment and Retraining Notification Act (“WARN”), we wish to notify you that Honolulu Country Club, LLC, now known as Honolulu Club, LLC, a Hawaii limited liability company (“HCC”) operates the Honolulu Country Club located at 1690 Ala Puumalu Street, Honolulu, is selling its assets including the Honolulu Country Club located at 1690 Ala Puumalu Street, Honolulu, Hawaii 96818 (the “Property”).

The Closing of the sale is currently scheduled for August 9, 2022, but this may change as the Buyer has proposed continuing the Closing to a later date. The buyer of HCC’s assets (“Buyer”) will be interviewing all Affected Employees (defined below) for employment with the Buyer under its wages, hours, benefits and other terms of conditions of employment. Buyer has informed HCC that it expects to retain all HCC employees.


