Jan – Guard Hawaii Inc. (the “*Seller*”) is selling substantially all of its assets relating to its standing guard and security patrol business to Universal Protection Service, LLC d/b/a Allied Universal (the “*Buyer*”). Seller’s primary office is located at 650 Iwilei Road, Suite 201, Honolulu, Hawaii 96817.

The transaction is complex and we will endeavor to promptly notify you of any important developments.

After the sale is completed, approximately 226 employees of the Seller will be permanently terminated. Under the Worker Adjustment and Retraining Notification Act and the Dislocated Workers Act, we are notifying you that the employees in the

classifications noted in Exhibit A will be permanently terminated on or about March 14, 2022, and there will be no right of bumping. Exhibit A contains, by location, a listing of the job title of positions affected and the number of employees in each job classification.

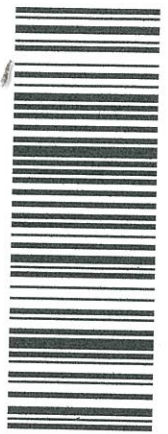
