Dear Ms. Perreira-Eustaquio:

This is to notify you that while we have seen a modest increase in travel to our islands since the rollout of Hawai'i's pre-travel testing program and nationwide administration of COVID-19 vaccines, the pandemic continues to negatively affect Hawaiian Airlines, Inc. (the "Company"). The Company has made changes to adapt to the unprecedented challenges that the airline industry faces, including modifying the frequency of flights to accommodate drastically altered market demands, offering special and discounted fares and implementing multi-layered procedures to ensure that our passengers are flying in a safe and healthy environment.

The Company recently requested and is receiving additional financial support offered to passenger air carriers through the extension of the Payroll Support Program under the CARES Act ("PSP2"). With such assistance, the Company was able to recall or otherwise provide compensation and benefits to those of our employees who were affected by the Company's reduction in workforce last year. However, with PSP2 funding expiring on March 31, 2021, and despite our ongoing cost-saving efforts and changes to our business to generate more revenue, the Company does not anticipate that it will be able to retain all employees beyond March 31, 2021. Consequently, effective April 1, 2021, or during the 14-day period thereafter, the Company will likely invoke layoffs of its unionized employees in all its Hawai'i locations¹ as described below:

Although these furloughs will be temporary,² we anticipate that the duration of the furloughs will last six (6) months or longer.


There are some factors that may require the Company to modify this notice. The number of involuntary furloughs may also be reduced if there is significant participation in the Company's voluntary early out program. A material improvement in demand conditions could also enable us to increase our schedule beyond March 31, 2021. Therefore, the Company is unable to determine with precision which or how many of its union employees will be affected by this planned action.

Exhibit A is a listing of the job classifications/titles and number of Hawai'i-based employees who are presently expected to be affected by the Company's reduction in its workforce. Exhibit B lists the unions and union representatives who have been notified of the anticipated furlough date affecting their respective members.

This letter is intended to fulfill any notice requirements that may be imposed under the Worker Adjustment and Retraining Notification Act ("WARN Act") and/or state law, but should not be construed as a concession that notice under the WARN Act and/or state law is required.
