Dear Mayor Blangiardi and Ms. Perreira-Eustaquio,

Pursuant to the Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2107(a) and the Hawai'i Dislocated Workers Act, Haw. Rev. Stat. Chapter 394B, this is to inform you that **Pharmacare International ("Pharmacare")** will be permanently shutting down and/or ceasing its operations at three of its locations and permanently laying off its employees at these locations on or about October 23, 2022. This permanent closure and layoff are dependent on the completion of the sale of three of Pharmacare's locations. If there are any changes in the status of the sale, an update will be provided in writing in accordance with federal and state law.
