

Homelessness

Homelessness or houselessness is the state of being unhoused or unsheltered; lacking stable, safe and adequate housing. People are homeless if they are:

- Living on the street
- Moving between temporary housing (i.e. couch surfing)
- Living in private boarding housings with no private bathroom
- Living out of car, at the park, or beach

Future vs Immediate (and Final)

- The VA is made up of 3 different administrations, VBA, VHA and NCA.
- VA Benefits provides VA Homes Services, these are "Future" housing supports
- VA Hospital provides VA Homeless Services, these are more Immediate or direct supports
- NCA provide VA burial services, the final resting place for Veterans.
- ALL service have specific criteria and requirements for a veteran to be eligible (i.e., Veterans with a dishonorable discharges are typically not eligible for most service or benefits).

Trends


- Veterans (and to a certain degree VA and non-VA staff) often are under the belief that all Veterans are "entitled" to all VA benefits,
- Veterans often seek out employment similar to what they did in the military, because its familiar, this can be a barrier.

Veteran Makeup

- The Veterans of this generation (Post-9/11) are more diverse in gender, race and ethnicity than those that served in prior wars
- According to BLS Veteran unemployment rates were lower than the general population, however among Post 9/11 Veterans unemployment is higher and the highest is among female Veterans
- Far more likely to have a college degree or higher as compared with the general homeless population

Short-Term Employment Supports

- Homeless Veteran Community Employment Services (HVCES)
- Compensated Work Therapy (CWT)
 - Several different programs

Long-Term Employment Supports

- Vocational Readiness & Employment (VR&E)
 - 5 different programs

VA Employment Services Benefits

VA Referrals

Working closely with VA staff and programs to identify and provide employment services including long-term voc rehab and supported employment services.

Employers Engagement

Partner with employers to help them fill vacancies on island with job-ready veterans how have experienced homelessness.

Community Collaboration


Collaborating with Dept of Labor program such as VETS, HVPR and DVOP as well as local providers like Catholic Charities, the UH System, and US Vets.








2021 FY Highlights

- Appx. 5100 Veterans exit homeless residential programs with competitive employment.
- More than 10,300 Veterans were employed at the exit from all VHA homeless programs and services
- Employment for Veterans housed thru HUD-VASH exceed that national target despite the impact of COVID-19 on employment nation-wide
- Employment Coordinators continue to utilize telehealth and telephone visits as well as develop strategies for providing employment services and support thru virtual platforms, including virtual job fairs.
