Please be advised that, as of April 3, 2024, TEG Hotels, LLC will engage Highgate Hotels to manage Best Western The Plaza Hotel located at 3253 N. Nimitz Hwy, Honolulu, HI 96819 and the Airport Honolulu Hotel located at 3401 N. Nimitz Hwy, Honolulu, HI 96819. TEG Hotels, as Owner of the hotels, is currently the employer of the employees who work at the two properties. Outrigger Hospitality Group is the Manager/Operator. Highgate will assume management of the operations of the hotels and will employ all of the current employees pursuant to a hotel management agreement with TEG Hotels.

Although there will be no closing or shutdown and no loss of employment and, therefore, notice under the Hawaii Dislocated Worker Act and the Federal Worker Adjustment and Retraining Notification Act may not technically be required, this notice is given for the avoidance of doubt and controversy. For the purpose of completeness, we advise you that this transaction will not trigger the employees' seniority or bumping rights.
