    - Artificial Intelligence (AI)
    - SkyScape Vertiports
  - Finding ways to fill the employment gap with apprenticeship programs and career pathways with below partners
    - o Commercial driver's license (CDL) Training Licensure

      - Aviation, drone competition

    - Hawaii Oral Health Coalition

- Chair Miyashiro is currently working with labor unions and Hawaii Employers Council on the Workforce Development Diploma & Career Foundation Certificate.
- Chair Miyashiro is utilizing the Longitudinal Data System (LDS)
  - This is a tracking system that tracks an individual from school, training, and job placement
  - Do students stay within their pathway or do they end up in another career field?
  - Did the pathways give skills and knowledge that are applicable to any and all career fields?
  - Do they prepare students for jobs of the unknown future?

Keala Richards suggested an off-line discussion with Chair Miyashiro, Dan Doerger, and Bennette Misalucha to discuss how to align and integrate efforts with the committee and Good Jobs Hawaii. Dan Doerger agreed that it would be a good idea to share best-practices, lessons learned, and review additional funding sources.

Tui Scanlan noted that AI impacted the recent Writer's Guild and Actor's Strikes in the entertainment industry.

Bennette Misalucha asked who the ideal candidates for this program are, and what type of outreach Erin Yagi was doing. Erin Yagi confirmed that they are still in the planning stages for outreach.

Bennette Misalucha also asked if there is any representation in teachers, specifically from the Micronesian / Compacts of Free Association (COFA) population. Erin Yagi agreed that was a good suggestion.

Mark Menard asked how long it takes to get certified. Erin Yagi confirmed that it takes 3 semesters or 18 months. Mark Menard asked if they are on the Eligible Training Providers (ETP) list. Erin Yagi said she would follow up. Mark Menard confirmed he would double check if they submitted an application.

Chair Miyashiro asked if any unions have reached out to Erin Yagi, and if a union member is allowed to teach. Tui Scanlan advised that most union members did not attend traditional four-year colleges, and that most of the training is done on the job.
