I. Call to Order

The Special Projects Committee meeting was called to order at 11:01 a.m. by Chair Keith DeMello

II. Approval of Minutes

A. October 16, 2023 Meeting Minutes

Chair DeMello requested a motion to approve the minutes for the October 16, 2023 meeting. Since none of the attendees from October 16, 2023 meeting were present, the approval of minutes was deferred to the next meeting.

III. Executive Director's Report

Chair DeMello reconfirmed that the end of the public comment period for the first draft of the Unified State Plan is February 16, 2024.

Mark Menard announced that there is a hiring event for high school seniors on April 16, 2024. He mentioned that the minimum hourly wage is around \$18 per hour, so that it's aligned with the Asset Limited, Income Constrained, Employed (ALICE) living wage threshold.

IV. Update on Efforts Around Temporary Job Opportunities Following the Maui Wildfires Debbie Cabebe shared a presentation. Bennette Misalucha asked how many people have benefitted from the grant. Debbie Cabebe advised there are 400 applicants. Out of the 400 applicants, 100 found employment, and 65 are ready for employment / are in the que. She noted that some don't follow up or realize they applied to the wrong program. Out of the \$21M grant funding, \$10M has been received. They have two years to spend the funds with the possibility of an extension.

Bennette Misalucha asked Debbie Cabebe what challenges she faced. Debbie Cabebe answered that she felt they were on target and that they are doing a good job.

Mark Menard pointed out that their program is similar to the Quest grant / internship program. Currently there are 100 people enrolled in the Quest program. Debbie Cabebe confirmed that

their program is less restrictive than the Quest grant and the focus is on quick employment. Bennette Misalucha asked if the applicants are not qualified or if they don't follow up on their paperwork, can they refer them to other partners like the American Job Centers or within Maui Economic Opportunity (MEO).

V. Updates from American Job Center, Hawaii County

Bennette Misalucha noted that she is inviting members of the Maine Workforce Board present best-practices for supporting justice-involved and at-risk youth sometime in May or June 2024. Denise Pacheco mentioned that, with the help of the Workforce Development Division and Maricar Pilotin-Freitas, they hosted a Justice Involved Summit on the Big Island in August 2023. She also noted that Going Home Hawaii has 50 partners statewide.

Bennette Misalucha asked what the enrollment for at-risk youth is. Denise Pacheco said that she would check with Goodwill Industries, who is the Workforce Innovation and Opportunity Act (WIOA) provider and will get back to us.

VI. Update on Legislative Efforts

Chair DeMello shared a list of workforce development related bills that he is currently monitoring. The bills include HB 2199 and SB 2351; HB 1827 and SB 3225; HB 2271, HB 2575, SB 2291, SB 2943. He noted that HB 1827 passed the first committee.

Chair DeMello noted that last week was the deadline for triple-referral bills to be heard in their first committee. As part of the continuing legislative process, the next major deadline (First Lateral) is for bills to be heard in their final committees.

Lisa Simmons asked if he was tracking SB 560. Chair DeMello advised he was not, but he would add it to his list.
