In 2022, the Partners in Development Foundation (PIDF) and its collaborators were awarded an eight-year, \$20 million grant from the W.K. Kellogg Foundation to support their joint efforts in the Kawailoa project, which focuses on restorative initiatives aimed at decreasing youth incarceration.

The Kawailoa project seeks to transform the youth justice system by replacing incarceration with a Native Hawaiian restorative approach—one that strengthens communities, equips youth with healing skills, and

reallocates resources toward culturally-rooted, community-led support systems. One of the partners in the project is Kinai Eha.

Kinai Eha is dedicated to supporting Native Hawaiian youth who are at risk of leaving school or encountering life difficulties. With a strong emphasis on personal growth and alternative education, the organization offers traumainformed, values-driven programs that incorporate hands-on training in construction, opportunities for community service, and activities that strengthen cultural identity. Operating primarily in the Koʻolaupoko area, Kinai Eha works to break the patterns that often lead to incarceration by providing intensive guidance and support. Their impact is evident in meaningful outcomes such as helping participants achieve vocational certifications and stable housing.
