PURPOSE

The purpose of this bulletin is to provide Local Areas with the amended Program Year (PY) 2025 allocations for the Adult and Dislocated Worker Programs under Title I of the Workforce Innovation and Opportunity Act (WIOA), and the amended funds available for the Local Administrative Cost Pool.

BACKGROUND

The Training Employment Guidance Letter 11-24 from the Employment Training Administration, issued May 20, 2025, provided the 2025 allotment levels for the WIOA Youth, Adult, and Dislocated Worker Programs. WIOA Bulletin. 02-25, Change 1 provided the local area allocations based on the allotment.

On July 30, 2025, the Department of Labor and Industrial Relations received the WIOA Adult Program Notice of Award (NOA) for \$599,821 and WIOA Dislocated Worker Program NOA for \$486.734 on August 4, 2025.
