Dear Rapid Response Coordinator:

We are writing to inform you that C&S Family of Companies will conduct employee separations due to the outsourcing of certain customer service functions. This action will impact some of our employees who work at or report into the locations listed on Exhibit A to this letter. This action is expected to be permanent.

This notice is supplemental to the notice dated January 8, 2025 submitted previously and is based upon the best information available to the Company at this time. We expect that the next losses of employment will occur within the 14-day period beginning on **April 30, 2025**.

Exhibit A includes the locations where affected employees work or into which they report, the addresses of the impacted facilities, the names of the entities that employ these employees, affected job titles, the number of affected employees in each job title, as well as the employees' anticipated separation dates.

The affected employees are not represented by a union.

There are no bumping rights for any impacted employees.

Although we have no obligation to provide you with advance notice of these employee separations, we are providing this notice to allow you provide any assistance available for our impacted employees in Kapolei, HI.
