We are writing to inform you that effective June 30, 2025, or anytime during the 14-day period thereafter, **Oshkosh Airport Services** (the "Company") will begin terminating employees as a result of the Company ceasing operations at its Honolulu, Hawaii Airport location due to the loss of the Company's contract with **Airlines Committee of Hawaii, Inc. Daniel K. Inouye International Airport**. The terminations will impact the Company's operations located at the Honolulu, Hawaii Airport, 300 Rodgers Blvd, Honolulu, HI 96819, and the terminations will be permanent.

A total of 119 employees, 70 employees at the Daniel K. Inouye International Airport, will be terminated as a result of the Company ceasing operations at this location. Employees are not represented by a union and do not have any bumping rights. The Company has provided as much advance notice as is practicable of the terminations given the abrupt and unanticipated loss of the Company's contract with Airlines Committee of Hawaii, Inc. Daniel K. Inouye International Airport.

Additional information concerning this matter may be obtained from Matt Kreuscher, HR Director, Oshkosh AeroTech. The job titles of positions to be affected, number of affected employees in each job classification, and anticipated schedule for making separations is available upon request.

The information provided in this letter is based upon the best information available to the Company at this time. This letter is provided pursuant to federal laws which encourage employers who are not required to comply with the business closing notice statutes to, nonetheless, provide such notice, and should not be construed as an admission of coverage.
