
All employees of Entertainment America, Inc. will be offered a position at our Kapolei location at 700 Haumea Street, Kapolei, HI 96701.

If the closure occurs less than 60 days after the date of this notice, Entertainment America, Inc. will also pay all Pearl City location employees an amount equal to their wages and benefits until the end of the 60 days.

It is unlikely that any employees will lose employment due to the closure. If so, they may be eligible for a dislocated workers allowance, if they receive a determination of eligibility for unemployment compensation benefits from the State of Hawaii Department of Labor and Industrial Relations.
