Please see the update to our letter dated January 7, 2026, below.

Pursuant to the Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2107(a), and the Hawai'i Dislocated Workers Act, Haw. Rev. Stat. Chapter 394B, this is to inform you that **DFS Group L.P.** ("DFS") will be closing its operations in Hawaii commencing on January 28, 2026, and continuing through March 31, 2026. All Hawaii-based employees will be permanently laid off.

The following list identifies the location of each work site, the number of employees at each site and the number of employees who will be permanently laid off. DFS is non-union and there are no bumping rights available to employees.
