SUBJECT: Program Year (PY) 2025 Allocations

PURPOSE

The purpose of this bulletin is to rescind WIOA Bulletin No. 02-25 Change 2 which transmit the Program Year (PY) 2025 allocations for the Adult and Dislocated Worker (DW) Programs under Title I of the Workforce Innovation and Opportunity Act (WIOA).

BACKGROUND

The Training Employment Guidance Letter 11-24 from the US Department of Labor (US DOL) Employment Training Administration, issued May 20, 2025, provided the State with the PY 2025 allocations for the Youth, Adult and DW Programs as provided below:

Youth Program	\$ 3,024,364
Adult Program	\$ 3,082,097
Dislocated Worker Program	\$ 2,280,320
Total	\$ 8,386,781

WIOA Bulletin No. 02-25, Change 1, transmitted these amounts to the local areas. PY 2025 allocations for the Youth, Adult, and Dislocated Worker Programs under the Title I of the WIOA. Because the State received the Notice of Award for the first incremental funding amounts, WIOA Bulletin No. 02-25, Change 2 transmitted the reduced amounts to the local areas

as shown below:

Adult Program	\$ 599,821
Dislocated Worker Program	\$ 486,734
Total	\$1,086,555

On October 10, 2025, US DOL issued to the Department of Labor and Industrial Relations (DLIR), the Notice of Award (NOA) for the WIOA Title I Adult and Dislocated Worker Programs for the second incremental funding, which reverted the allocation to the full funding amounts transmitted by WIOA Bulletin No. 02-25, Change 1, dated May 29, 2025.
