

Exhausted Unemployment Insurance Benefits

File for PEUC (first 13 week extension).

Exhausted UI benefits before December 26, 2020.

After exhausting PEUC 13 week extension, eligible for the PEUC 11 week extension.

Exhausted UI benefits.

Exhausted UI benefits on or after December 26, 2020.

Wait for PEUC 11 week extension. You will receive retropay for back weeks.

We will announce the launch of the PEUC 11 week extension after receiving guidance & funding from the U.S. Department of Labor and when UI system programming is complete.

After exhausting PEUC 11 week extension, eligible to receive 13 weeks of EB20.



PEUC Remaining Balance

Has a remaining balance on PEUC claim.

Continue to file claim certifications.

No application required, wait for program implementation no gap in benefits but receive retropay for the missed weeks

We will announce the launch of the PEUC 11 week extension after guidance & funding are provided by the U.S. Department of Labor and UI system programming is completed.



Exhausted PEUC 13 week Benefits On or After 12/26/20

Exhausted PEUC 13 week Benefits on or after 12/26/20.

Eligible for PEUC 11 week extension.

No application required, wait for program implementation - no gap in benefits but receive retropay for the missed weeks.

We will announce the launch of the PEUC 11 week extension after guidance & funding are provided by the U.S. Department of Labor and UI system programming is completed.



Exhausted PEUC Benefits Before 12/26/20

No gap in benefit payments.

Must exhaust all EB20 benefits, may be eligible for PEUC 11 week extension if EB exhausted before 3/13.

File for EB20.*

Exhausted PEUC Benefits before 12/26/20.

*If you filed for EB20 after December 13, 2020, your claim is not being processed. You will be notified regarding your decision to apply for EB20. Wait for PEUC 11 week extension.

Will have gap in benefit payments.

After exhausting PEUC 11 week extension, eligible to receive 13 weeks of EB20.



Exhausted EB20 Benefits

Exhausted EB20 benefits.

Eligible for PEUC 11 week extension.

No application required, wait for program implementation no gap in benefits but receive retropay for the missed weeks

We will announce the launch of the PEUC 11 week extension after guidance & funding are provided by the U.S. Department of Labor and UI system programming is completed.



Receiving PUA Benefits

Sole proprietor, independent contractor, disqualified from UI, etc. Keep filing claim certifications.

Continue to receive benefits.

Exhausted PEUC and/or EB20.

Move back to UI to receive the PEUC 11 week extension.

UI will notify you about the next steps.

We will announce the launch of the PEUC 11 week extension after guidance & funding are provided by the U.S. Department of Labor and UI system programming is completed.
