#### I. Call to Order

Chair Cary Miyashiro called the meeting to order at 1:00 p.m. The meeting was held remotely via Zoom, with a physical meeting location available at 830 Punchbowl Street, Room 310, Honolulu, HI 96813. Chair Miyashiro acknowledged the presence of Vice Chair Lorna Woo from the International Union of Painters and Allied Trades. The meeting was conducted as a public meeting under the Open Meeting Law, with staff from the Department of Labor and Industrial Relations present.

# II. Student Operated Health Clinic @ Waipahu High School

**Presenter:** Shelli Ihori, Hawaii Pacific Health Systems. Scheduled presenter Carl Hinson was unable to attend.

Shelli Ihori provided an overview of the Student Operated Health Clinic at Waipahu High School, the first of its kind in the country. The clinic is a partnership between Hawaii Pacific Health and the Department of Education, allowing high school students to gain hands-on experience in healthcare while serving their community.

### **Key Points:**

- The clinic opened in April 2024 after construction began in July 2023.
- It serves as a school-based care facility for the Waipahu community, with students shadowing physicians and gaining real-life experience in both administrative and clinical roles.
- The clinic features four exam rooms, one treatment room, and a telemedicine system.
- Students from various academies at Waipahu High School, including Health Services, Communications, and Arts, contribute to the clinic's operations.
- The program primarily targets seniors but is open to students from all grades interested in healthcare careers.

#### **Discussion:**

- Bennette Misalucha asked about metrics for success. Shelli Ihori explained that
  the primary goal is to serve the vulnerable population in Waipahu, with success
  measured by community engagement and student participation.
- Monica Lortz inquired about the program's duration. Shelli Ihori clarified that the
  medical assistant training program runs from August to May, with 225 hours of
  externship required before students sit for their national certification exam.
- Ephraim Schwab suggested collaborating with community providers to refer
  patients to the clinic. Shelli Ihori expressed openness to such partnerships once
  the clinic is fully operational.

### III. Approval of Minutes

Chair Miyashiro announced that the approval of minutes from the June 30, 2024, meeting would be deferred to the next meeting due to technical issues.

# IV. Hawaii Employer's Council Presentation

Presenter: Sarah Guay, President/CEO

Sarah Guay provided an overview of the Hawaii Employer's Council (HEC), a nonprofit organization that supports employers in Hawaii through HR consulting, training, and compensation surveys.

# **Key Points:**

- HEC serves over 750 member organizations, representing 172,000 employees across various sectors.
- Services include HR advising, employee handbooks, policy templates, and training programs such as the Fundamentals of Supervision and Management Development Program.
- HEC also offers compensation data and surveys to help employers remain competitive in the labor market.
- A new service, Continuous Improvement and Lean Six Sigma, was introduced to help small businesses improve efficiency.

#### Discussion:

- Chair Miyashiro highlighted HEC's role in assisting the Department of Education with salary range research for vice principals.
- Sean Villegas inquired about upcoming events. Sarah Guay directed attendees to HEC's website for the event calendar.

#### V. Bay Valley Tech Presentation

**Presenters:** Phillip Lan, Justo Licona, and Sean Villegas
Phillip Lan and Sean Villegas presented on Bay Valley Tech, a California-based
organization offering free digital skills training programs, including coding, digital
marketing, and tech sales.

#### **Key Points:**

- Bay Valley Tech provides flexible, employer-driven training programs to address the tech talent shortage.
- Students are required to give back to their communities by volunteering or mentoring after completing the program.
- The organization has trained over 2,500 students, with many securing jobs at companies like Apple, Google, and Tesla.
- Bay Valley Tech is expanding to Hawaii, with a team arriving the following day to explore partnerships and training opportunities.

#### **Discussion:**

- Bennette Misalucha inquired about financial sustainability. Phillip Lan explained that
  the program is volunteer-based and funded through grants, contracts, and
  partnerships with local agencies.
- Monica Lortz expressed interest in collaborating to provide training for individuals exiting the corrections system.

#### VI. Executive Director's Report

**Presenter:** Bennette Misalucha, Executive Director, Workforce Development Council Bennette Misalucha provided updates on several initiatives:

- **State Workforce Unified Plan:** Submitted to the U.S. Department of Labor on March 4, 2024, with plans to brief the Director and Governor.
- Transition to DLIR: The Workforce Development Council is transitioning to an attached agency under the Department of Labor and Industrial Relations, effective July 1, 2024.
- Long-Term Care Workforce Task Force: Efforts are underway to develop a master plan for long-term care in Hawaii.
- **Upcoming Events:** September is Workforce Development Month, with events including a Future of Work conference and the Workforce Development Heroes awards.
